

CIR-12 - Bulk Loans

Supercedes: Last Revision

**Policy Statement** - In order to meet the educational, recreational and informational needs of our customers, the Camden County Library System provides loans to schools and assisted living facilities located in member communities.

## Regulations

#### 1. School Media Centers

- 1.1 May borrow up to 50 fiction and 50 non-fiction books for a loan period of 3 months.
- 1.2 New media centers may borrow 200-300 fiction books and 100 non-fiction books for the school year.
  - 1.2.1 An additional 25 non-fiction books may be borrowed for 3 months to supplement subject material.
- 1.3 Audiovisual materials are not available for school loans.
- 1.4 Selection of books may be done by the school librarian or by the staff of the Camden County Library System's Children's Department.
  - 1.4.1 Teachers must contact their school librarian before selecting books.
  - 1.4.2 Up to 3 titles may be requested by phone.
  - 1.4.3 Requests for 4 or more titles must be submitted in writing.
- 1.5 Bulk loans will be delivered and picked up by the Camden County Library System Delivery Service to the following schools:

John Glenn School
Loring Fleming School
Somerdale Park School
Stoy School
Strawbridge School
Van Sciver School

- 1.5.1 All other schools must make their own arrangements for pick up and return of books.
- 1.6 Bulk loan items to schools may not be renewed.
  - 1.6.1 There are no fines for late returns.
- 1.7 The school assumes full responsibility for lost or damaged books.
  - 1.7.1 The Camden County Library System reserves the right to suspend the borrowing privileges of any school that does not pay for lost or damaged books.

#### 2. Pre-Schools

- 2.1 Bulk loans of picture books will be made to school system pre-schools and non-profit federally funded or church-sponsored nursery or pre-schools in member communities.
- 2.2 May borrow up to 25 books for a loan period of 3 months.
- 2.3 Paperbacks and audiovisual materials are not available for loan.
- 2.4 Selection of picture books may be done by the staff of the nursery school or by the Camden County Library System's Children's Department.
  - 2.4.1. Up to 3 titles may be requested by phone.
  - 2.4.2. Requests for 4 or more titles must be submitted in writing. must be submitted in writing.
- 2.5 Bulk loans will be delivered and picked by the Camden County Library System Delivery Service to the following schools:

### **Barrington PreSchool**

- 2.5.1 All other schools must make their own arrangements for pick up and return of books.
- 2.6 Bulk Loan items to schools may not be renewed.
  - 2.6.1 There are no fines for late returns.
- 2.7 The school assumes full responsibility for lost or damaged books.
  - 2.7.1 The Camden County Library System reserves the right to suspend the borrowing privileges of any school that does not pay for lost or damaged books.

# 3. Assisted Living Facilities

- 3.1 May borrow up to 40 items for a loan period of 3 months.
- 3.2 There is no restriction on type of media.
- 3.3 Selection of items will be done by designated Library staff on a monthly basis.
- 3.4 Bulk loans will be delivered and picked up by designated Library staff for the following facilities:

- 3.5 There are no fines for late returns
- 3.6 The facility assumes full responsibility for lost or damaged items.
  - 3.6.1 The Camden County Library System reserves the right to suspend the borrowing privileges of any facility that does not pay for lost or damaged material
